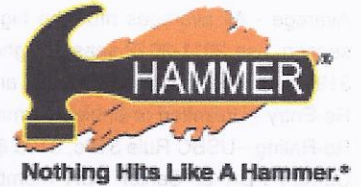

TOURNAMENT RULES

(Failure To Read Is No Excuse)

HANDICAP DIVISION (Men & Women)

1. Eligibility - Eligibility - All 2011-2012 TNBA & USBC certified bowlers.
2. Entries close March 11, 2012 at 2:30 PM (Last Squad). Reserved entries must be accompanied by a certified check or money order. (NO PERSONAL CHECKS WILL BE ACCEPTED). No entry will be accepted where application is not fully completed. Walk-in entries will be accepted based on availability..
3. Handicap - 100% of 220 scratch for Women.
100% of 220 scratch for Men.
4. Tournament Format- Three (3) games on a pair of lanes.
5. Average - All averages must be highest 2010-2011 certified league averages for 21 games or more. If no league average for the 2010-2011 season, use 2011-2012 season highest average for 21 games or more, at the time of bowling. All others will bowl scratch. USBC Rule 319a-2 & 319a-3 applies. Summer averages are not accepted.
6. Re-Entry - Unlimited re-entries permitted, however, each entrant may cash only once in the Handicap List. (USBC Rule 315c).
7. Re-Rating - USBC Rule 319c, 319d & 319e will apply to all entrants.
8. Current PBA or Senior PBA members, regardless of classification, will not be permitted to bowl in TNBA tournaments. Past PBA/PWBA champions, regardless of classification, may be permitted to bowl if their championship was not within the last 10 years. Former PBA/PWBA members who have not held a card for the past two (2) years are eligible to bowl in TNBA tournaments.
9. Prize fund will be paid 100%. Prize ratio will be at least one (1) prize for every ten (10) entries.
10. Unattached Cards - TNBA - \$25.00, USBC - \$21.00. Cards may be purchased at the Tournament site.
11. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or therefrom; fires, strikes, lockouts, labor difficulties or other reasons beyond the control of the Bill Rhodman Classic, shall cause the foregoing prize schedules to be prorated in accordance with the number of entrants who have bowled.
12. All rules not stated above will be governed by TNBA and USBC rules.
13. Anyone employed by Stelton Lanes from January 1, 2012 until the end of the tournament is not eligible to bowl..
14. The Tournament Director will make all decisions and reserves the right to refuse or reject any entry.
